This was an unannounced site inspection. The site inspection was undertaken by regulating officer Andrew Sowerby.

I was informed that the TCMs for the site are Ian Crawford and Mark Richards. The site diary indicates they regularly visit site.

At the end of the site inspection I asked if there was a copy of the environmental permit and the sites Environment Management System on site. Staff on site were unable to find the copies. Please ensure that these documents are available on site for staff to refer to should they need to.

Walked around the site in the company of a site employee. I was informed that the co-mingled waste is sent to UPM, The mixed waste is sent to Thorncliffes or Hafod Landfill, green waste is sent to Llandulas and the food waste is sent to the Biogen AD Plant in Rhualt..

Overall the site was tidy and well organised and apart from the missing permit and EMS no issues were observed.

Breach

G4 - Monitoring and records, maintenance and reporting - Permit Condition 4.2.1 - CCS Cat 4

Permit Condition 4.2.1 states that "Within one months of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose,"

Quarterly waste returns are missing for Q1 2017 (Jan to Mar 2017) and Q2 2017 (Apr to June 2017). Please submit these waste returns as soon as possible using the form NRW provides. You should also bear in mind that the waste returns for Q3 2017 are due by the end of October 2017. All missing Q1 and Q2 waste returns must be submitted by the 3rd November 2017.

Failure to submit waste returns is regarded as a breach of the permit and on this occasion a CCS Cat 4 has been applied.
