This was an unannounced inspection carried out by regulating officer Steven White, site manager David Evans was not on site during the visit.

There was a lot of mud observed on the tracks in and around the site, a modified bowser/sweeper is usually in operation on the site to combat any dust issues that could arise from this should the weather dry out. This bowser was not being used at the time of the visit but after talking to a site operative it was scheduled to be deployed the next day; with the amounts of fine mud that were observed you will need to keep on top of the sweeping of the tracks in order to ensure that any dust that could arise from machinery/wagons is kept to a minimum.

The 360 digger and trammel were operational whilst I was on site - there were no issues observed with these

WRAP aggregate material was segregated from other wastes/materials, there were some contaminants visible in the waste on site (see photo below), these are removed during the treatment process and disposed of.
