This was my first inspection of the site and as there has been no official handover from the previous regulating officer, I wanted to take the opportunity to better acquaint myself with it.

The site appeared to be tidy and well ordered and there were no breaches recorded on this occasion.

Despite there being no breaches recorded on this first visit to site there were a couple of issues that need to be addressed.

The first is with regards to the storage of any potentially polluting liquids on site. An oil drum was observed outside the shed on the hardstanding. Your permit states in Condition 3.1.3 that "all liquids in containers, whose emission to water or land could cause pollution, shall be provided with secondary containment". You should ensure that any drums of oils etc are kept either in a double skinned tank, within a bunded area or on a bunded pallet at all times. Should this be observed again then a breach will be recorded.

The other issue was with regards to dust. As I was leaving site you started treating some of the inert waste. I observed that this treatment process was generating a large amount of dust and that due to the dry and sunny weather conditions it was travelling a considerable distance towards the site boundaries. It is likely that any prolonged treatment of inert waste would have resulted in dust being blown off site. Before leaving I commented on this to you. Your activities on site should not have any impact on anyone off site. Should this occur then it would be regarded as a breach of your permit and appropriate action would be taken. As a minimum you should be ensuring you comply with the conditions regarding dust set out in your environment management system (version 1, section 4.4).
