The purpose of the inspection was to view progress on the construction and commissioning of the new waste treatment plant.

As the photographs below show the main treatment equipment has been installed and the installation of the electric cabling and boards is now being undertaken. Once this has been completed the equipment will be commissioned and fine-tuned for the treatment of the material. Once the plant is up and running material will be accepted direct from the main waste contract and material that has currently been stockpiled at the Llandarcy site.





A small amount of plate glass has been accepted on site and as such the permit is now operational. The plate glass can be seen in the photograph below.



As the permit is now operational please ensure that relevant parts of the environment management system are implemented. For example, waste returns will need to be submitted for the plate glass accepted.
