Regulating Officer James McClymont accompanied me during the site inspection.

We met Stuart Butterworth, the TCM for both this site and the Delyn Gwespyr site.

We were informed that the site owner Joseph Mound intends to close the gates at the Gwespyr site and move operations to Point of Ayr. There is currently no timeframe for this to take place.

We had a walk around the site. There is a lot of metal and other products, some of which are not regarded as waste currently being stored on the site. Before the site becomes operational it will need to be cleared and the infrastructure checked to ensure it is suitable, i.e. checking surfaces are impermeable where needed, bunded areas where appropriate, drainage functioning, the site fully secure etc.

The permit and associated documents will also need to be reviewed to ensure all the activities you plan to carry out on site and all the waste types that will be accepted are listed. You also need to ensure they are up to date and compliant with current guidance. For example the site will need an updated environment management system that complies with the guidance on our website.

During the site inspection it was suggested that a site meeting be arranged to discuss all these things. Please be aware that all these checks, repairs and documents will need to be done and in place before the site starts accepting waste again. Therefore, if you would like to arrange a site meeting it may be better to do it sooner rather than later. Please contact me when you are ready to meet so that we can agree a date.
