Comments

The inspection was carried out in order to check what activity has occurred on the site recently. Accompanied on site by Environment Officer Leon Williams and Delyn Metals Site Manager Stuart Butterworth.

No decision has yet been made regarding Planning Permission for the site. This means the site is not currently operational and that much of the waste metal on the site has been there for a number of years. However, indications are that the planning should be determined one way or the other in the next few weeks. If planning permission is granted then the intention is to start storing and treating waste at the Point of Ayr site as soon as possible.


Prior to the site becoming operational again it is suggested that an onsite meeting takes place to discuss the intended activities, site infrastructure and layout, the permit and associated documentation.

The most recent variations to the environmental permit were issued in May 2007 and November 2008 and should be reviewed well in advance of operations commencing to ensure that it can still be complied with. If the permit no longer seems to be suitable then it may need to be varied. The determination period for an application to vary a permit can take 4 months, and that's assuming that all information required is submitted.

An updated Environment Management System (EMS) will also be required. The Working Plan we have on file was produced in September 2006 and is unlikely to be compliant with current guidance on what is required from an Environment Management System.
