Hi Ross,

Further to our conversation last week regarding Kevin Humphrey's WTS, I can confirm that the equipment onsite will comprise:

- A sorting line consisting of
 - Bag opener
 - Overband magnet
 - Trommel
 - Manual picking line
 - Mechanical separation of process fines
- Baler (for recyclates)
- Compacter (for residual waste)

I have attached a flowchart for the proposed facility.

The purpose of the facility is to prepare waste for recovery and it is estimated that >80% of the waste will be destined for recovery.

I believe we are looking at a variation from a standard rules permit SR2008No5 to standard rules SR2008No7 as the proposed facility complies with the new standard rules set. Within the OPRA charging schedule a variation of a standard facility to become subject to different standard rules incurs a fixed rate application charge relating for the new standard rules.

I will be happy to provide additional information if needed and would be grateful if you could let me know if you consider an alternative permit is needed.
