4. Details of our assessment

A number of complaints were received on the evening of 08/01/22 regarding a loud and disturbing drilling and banging noise beyond 22:00hrs. Further complaints of the same noise were received on the Sunday 09/01/22 from 08:00hrs.

On investigation, the noise was confirmed to be associated with the maintenance work of wrecking kiln refractory brick.

Despite being essential, this activity is known to be noisy and likely to cause annoyance. As such, the Operator's Noise Management Plan restricts this activity to between the hours of 07:00 - 22:00.

On this occasion the activity was confirmed to have over-ran the 22:00hrs mark. Upon notification to the site the issue was swiftly addressed by site management, with this noisy activity confirmed to have ceased by 00:11hrs.

NRW considers this a breach of Condition 1.1 (C1 (Staff Competency and Training - CCS3))

ACTION: The Operator should ensure contractors are appropriately trained and supervised where environmental controls apply. Please respond to NRW in writing to confirm how this is achieved by 31/03/22.
