Hafod Quarry Landfill Site Cell 4 Western Upper Sidewall Extension CQA Plan (July 2019 v1.2)

We have reviewed the CQA Validation Report for Cell 4 Western Upper Sidewall Extension CQA Plan at Hafod Landfill.

The Operator has prepared the Plan in line with a series of previously approved plans. The engineering described in the Plan and shown on the drawing has a long history of use at the site and the Plan follows a well-established format. No new characterisation of the clay source is required as the previously accepted characterisation report for the same source is being adopted.

The only typographical issue we have noted is that Table 3 required values for Density/Moisture Content is not provided but references Figure 2 of presumably a different CQA submission. With this minor issue amended the CQA Plan is accepted.
