4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment against Maxibrite Limited (hereafter Maxibrite) air and water monitoring returns for Q4 and their annual reporting to NRW.

NRW received the following from Maxibrite:

Emission Monitoring**• Air Emissions**

- A9 Particulate Matter - This was measured within the ELV as stated in the permit and is therefore compliant.

• Water Emissions, W1

- Temperature - All results were within permitted limits
- pH - All results were within permitted limits
- Ammonia - All results were within permitted limits
- Total Suspended Solids - All results were within permitted limits

Annual Reporting**• Performance 1**

Total Raw Material used was 1.0148tonnes. This is a very slight decrease on the results from 2020. This is continuing the trend with the site in lowering the total raw material being used.

• Energy Usage

The site used 646.087MWh of Electricity and 1,757.252MWh of Natural Gas in the year 2021. This equates to 0.03863MWh/tonne of electric being used and 0.044MWh/tonne of Natural Gas used. This is again showing a decrease from the year 2020.

• Water usage

The sites used a total of 41,141m³ of water in 2021. Of this, 1,400m³ was from the mains and 39,741³ was abstracted. There was an increase in the amount of water used from the mains but a decrease in the abstraction. However, this is a net decrease in water usage compared to 2020.

Site Review

The site produce a total 40,140tonnes of briquettes in the year 2021. Air Emissions have also decreased due to the site now only using the rotary drier and only emitting particulate matter.

Water releases to Mwyndy Brook are discharged with a reduced frequency and will try and discharge during wet periods to minimise the impact of suspended solids to the brook. No releases to water were made during April and June. Continued work has been made on site to reduce the energy required to make products as well as reducing the emissions that arise from the site. The site has stated they will continue to work to improve the efficiency on site into 2022.
