Annual Returns

Site sent forms A2, EW1, R1 and PI1 on time.

Permit conditions also require reports to be submitted on an annual basis. These were also received on time and acknowledged below.

A2 – Site measure NOx, Sox, CO, and particulates from the process and report on a quarterly basis. Limits are applied for NOx (400mg/m³) and Sox(100mg/m³). No limits to air were breached in 2021. The average figure for NOx was 233mg/m³. For Sox it was 9.56mg/m³, both well within the limit.

EW1 – Received and accepted.

R1 – 181.86 tonnes of hazardous waste were sent from the site for recovery. 47.7 tonnes of hazardous waste could not be recovered. There were 16,071 tonnes of non-hazardous waste through the site sent for recycling.

PI1 – Water used per tonne of product has dropped from last year but is still on a general upwards trend. Oil use is similar and is more than double the values produced 2012-2017. NOx production is on a downward trend and is generally half of previous yearly totals.

PC4.1.5 – Gas use was lower than the previous year but did not meet the target value. For electricity the target was narrowly missed. Oil use per tonne was exceeded by some ~40%.

PC4.1.4 – Noted and accepted in full.

PC2.8 – Noted that the site has a discharge consent and has implemented the Oil storage (Wales) legislation.

Complaints – NRW received no complaints against the site during 2021.
