2014 & 2015 Waste Returns Review

A review of the waste returns for permit number EPR-EB3836AC has been completed. The following issues were identified:

- EWC code 200199 (other fractions) was miss-consigned in the 2014 returns and the quarter 3 2015 and quarter 4 2015 returns. The amended returns have been resubmitted and the waste recorded under code EWC code 20 03 07 (bulky waste).
- In 2015, EWC codes 160504, 170802, 200101, 200102, 200108, 200121, 200126, 200133, 200139, 200199 had been recorded on the waste returns with a tonnage of '0'. In 2014, EWC codes 200134 and 200199 had also been recorded on the returns with a tonnage of '0'. Any waste with a tonnage of '0' should not be recorded on any waste return entry. Amended returns with these waste codes removed have been submitted to NRW.
- A CCS category 4 breach has been recorded for the submission of incorrect waste returns.
