4. Details of our assessment**Review of annual monitoring data for emissions to air and water and annual returns for permit YP3732LZ for 2021 returns****Emissions to Air**

Annual air monitoring from stack point (A2) reviewed, air emissions monitored for PM, Pb and VOC - noted all emissions well below permitted ELV's. The figures of 3.85 mg/m³ for VOCs, 0.087 mg/m³ for Lead and 0.2 for mg/m³ for Particulates are all well within the Permit ELV of 20, 0.1 and 1 mg/m³ respectively.

The recent rise in particulate emissions has been addressed with a planned maintenance activity of cleaning the stack pipe leading to the sampling point.

Air emission monitoring was conducted by MCERTS qualified contractors on 05/10/2021 and evidence provided as supporting documents reviewed in the Air OMA (to be finalised)

Emissions to Sewer

2021 emissions data for monitoring from point (S1) - noted emissions for Lead 0.0017 mg/l and 99.4 mg/l for COD are below permitted discharge limits of 1 and 125 mg/l respectively.

Annual Returns

Energy (E1) and waste data (R1) submitted for 2020 for permitted installation - no issues with submitted data. Its noted that since November 2019, when the site completed a programme of changing all of its internal factory lighting and external lighting (on roadways and externals of buildings) to LED technology. This has assisted in allowing the site to significantly reduce its electricity usage.

156 tonnes of CO₂ emissions for 2021 noted, although an increase since 2014 figures, there is still an overall reduction trend for the last 5-6 years. Reason for the uptake was due to picking up some more work for underwater 132kV cable in 2021, which calls for lead pipe within the design, hence the increase in energy usage for the period.

Environment Management System

During 9-12 August 2021, they successfully had their ISO 14001:2015 Environmental Management System re-certified with a different third-party audit body, RINA in a 4-day remote audit. No non-conformities were raised. An electronic copy of the certificate has been provided to NRW for evidence.
