Routine site inspection conducted by Environment Officer Leon Williams.

Officer was accompanied by Site Supervisor Peter Clarke during the inspection

The site appeared tidy and no amenity issues relating to dust, noise, odour, litter, pests or deposited waste on the roads were observed during the inspection.

Waste stored on site was well segregated in clearly labelled skips and containers.

No breaches in the sites security fencing were observed. Mr Clarke informed that the site had not experienced any recent break-ins.

Outgoing waste transfer notes were inspected in the sites office along with the site diary. All records were duly completed.

During the inspection, Officer noticed that a skip containing hardcore and rubble was present on site. With reference to Table 2.2 of the sites environmental permit, construction and demolition waste is not listed as a permitted waste type.

Following a discussion with TCM Dave Driver it appears that the operators have been using the sites old environmental permit from 2001. The permit was modified by the previous operators (SITA Wastecare Ltd) in 2007 and a number of conditions were removed from the permit.

The acceptance of a non-permitted waste type onto the site has resulted in a Category 4 breach.

We therefore request that the operator applies for an administrative variation of the permit so that additional waste types can be added onto the table of permitted waste types by the 20 April 2015.
