2015 - 2016 Waste Return Review

A review of the 2015 and 2016 waste return submissions for permit number EPR-BP3694VK has been completed. While there were no issues apparent with the 2015 waste returns, there is a minor coding issue with the 2016 returns. In quarters 1, 2, 3 and 4 2016 the code 20 01 11 has been used for mattresses, this is not the appropriate EWC code to use for this waste type. The correct EWC code to use for mattresses is 20 03 07 (Bulky waste). Please ensure that EWC code 20 03 07 is used to describe mattresses on any future waste returns.
