Compliance Assessment Report - Bryn Compost Limited – WP3995FY

Compliance inspection of the permit EPR-WP3995FY held by Bryn Compost Limited conducted by officer Jonathan Lee at 14:00 on 29th January 2018. Given the non-operational status of the facility, the inspection was conducted to give advice on permit surrender and complete final inspection of the permitted area. Jennifer Price and Beth Jones in attendance on behalf of operator. Weather cold and light snow.

No waste activities being completed within the permitted area at time of inspection, it was stated that no waste has been processed within the IVC building since February of 2017. No waste present within the permitted area.

The impermeable surface and associated drainage infrastructure were shown to be in good condition. No ongoing pollution risk to ground or water was identifiable at time of inspection.

Permit Surrender

With consideration of the points and having reviewed historical compliance information, it is recommended that a **low risk surrender** application be submitted to Natural Resources Wales.

Application forms A, E2, F1 and CC1 should be submitted alongside a H5 Site Condition Report which is completed in accordance with government guidance.
