4. Details of our assessment**Q4 Monitoring Returns:**

Received within the required timeframes as stated in permit AB3591ZQ.

Phosphate has exceeded the emission limit value in the permit of 2.5mg/l. The measured result was 2.64mg/l.

This is a breach of permit condition 3.1.2 which states:

The limits given in Schedule 3 shall not be exceeded. The emission limit value is 2.5mg/l expressed as 'Phosphate as P'

As a result this breach has resulted in a CCS3 (C3) non compliance which could have a minor environmental effect.

ACTION:

Investigate the root cause of this breach to prevent a re-occurrence and provide this information to NRW via a Schedule 5 notification.

It also does not appear that NRW were notified of this breach, permit condition 4.3.1 (b) states:

In the event of a breach of any permit condition the operator must immediately (i) inform Natural Resources Wales, and (ii) take the measures necessary to ensure that compliance is restored within the shortest possible time;

As a result of NRW not receiving notification of this breach this has resulted in a CCS 4 (C4) non compliance which has no potential environmental effect.

ACTION:

Complete a Schedule 5 notification for this breach (Part A and B) advising the reason why the breach occurred and the investigations and actions taken to rectify and prevent a re-occurrence, to be forwarded to NRW by the 23rd February 2022.

All other parameters were within the emission limit values in permit AB3591ZQ

Annual Monitoring:
