4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised to review several documents recently submitted to Natural Resources Wales (NRW) as required by various permit conditions.

Q4 Monitoring Returns

The results were reported within the timescales required by Permit Condition 4.2.3, Schedule 4, Table S4.1. Monitoring of emissions to air for Q4 October - December 2021 were submitted on 20/12/2021. Quarterly monitoring of all emission points and parameters subject to quarterly reporting required by Permit Condition 3.3.1, Schedule 3, Table S3.1 was undertaken for the relevant reporting periods. All results for emission points A1, A2, A3, A6 & A38 were within the emission limit values specified by Permit Condition 3.1.2, Schedule 3, Table S3.1.

Annual Report & Solvent Management Plan

The Annual Report was submitted via email on 31/01/22, within the timeframe defined by Permit Condition 4.2.2 and contained all necessary reportable data defined by this condition in relation to Schedule 4, Tables S4.2, S4.3 and forms specified in Table S4.4.

Furthermore, the operator is required by Permit Condition 4.2.5 to submit an annual Solvent Management Plan. This was received via email on 31/01/22 in compliance with the permit condition and contained the relevant information including the calculations for emissions points A5 & A37 and indicates the final derived figures. The final monitoring figures were also reported as per the annual monitoring requirements defined by Permit Condition 3.3.1, Schedule 3, Tables S3.1 & S3.4 for emission points to air A5 & A37. The results were compliant with the 3% limit.

Four Yearly Efficiency Reporting

The permit requires the operator to review and record details in relation to Energy Efficiency, Efficient Use of Raw Materials and Avoidance, Recovery and Disposal of Wastes produced by the activities. These requirements are placed on the operator by Permit Conditions 1.2.1(b), 1.3.1(b) & 1.4.2 respectively. The operator reviewed these areas and recorded them in the report which, was supplied to NRW via email on 04/11/21. This report was resubmitted on 30/11/21 to correct errors. Thank you for the resubmission. The report details all required areas, including explanations for trends over the four year review period.
