4. Details of our assessment

On 31 January 2022 a site inspection was undertaken by David Ellar of NRW, and accompanied on site by Steve Hemmings.

The purpose of the inspection was to assess compliance with a step in the Section 59

Notice for the removal of the process waste.

David Ellar provided the photographs and summary of discussions held on site to Sally Wakeford (NRW). We have concluded that you have complied with the step in the Section 59 Notice requiring the removal of the process waste from the left-hand side of the site, just past the weighbridge.

There is an amount of material at the side of the site still, which is described as an earth bank, although there is a small amount of plastics contamination within it. This is not the process waste which was defined in the notice.

The final step of the notice is to remove the residual waste destined for landfill. The deadline for which is the 30 June 2022.
