Review of waste returns data for 2016.

All returns for quarter 1 to quarter 4 2016 had been suitably submitted to Natural Resources Wales, in line with the requirements.

It was noted that EWC 010101 had been recorded on the returns as received, with the description 'dry mixed recycling'. It was discussed with the operator that the EWC and description did not match. Operator confirmed that this was a computer generated error and the waste in question should have been recorded as 200301. Please re-submit the affected waste returns with the correct EWC Code used.

During the review of data the following non-compliance with permit conditions was noted:

C3 General Management - Materials Acceptance. Permit Condition 2.2.1. CCS Score C4

During the review of records submitted it was noted that EWC Code 170503 (soil and stones containing dangerous substances) had been recorded as received on site in quarter 2 2016. This was discussed with the operator and it was clarified that the EWC and description of this material on the consignment note was incorrect and should have been coded EWC 170605 (construction material containing asbestos). This issue was not picked up during the waste acceptance procedures on site. EWC 170503 is not listed in the permit therefore should not have been accepted on site. This is a breach of permit condition 2.2.1 which states that wastes shall only be accepted if it is of a type and quantity listed in table 2.2, and it conforms to the description in the documentation supplied by the producer.

Action: Ensure that waste acceptance procedures are robust so that only waste types listed in the permit are accepted on site.
