A review of the 2016 waste returns submissions has been completed. Condition 4.2.2 of your permit requires waste returns to be submitted within 1 month of the end of each quarter. Unfortunately NRW have not received the waste returns for quarters 1 and 2 2016. This is a breach of condition 4.2.2 of your permit. As a direct result of this breach of permit condition a CCS score has been applied.

You are required to submit the missing waste returns for quarters 1 and 2 2016 to waste.returns@cyfoethnaturiolcymru.gov.uk no later than the 12th May 2017. You are also required to implement with immediate effect a management system to prevent this breach of permit occurring again in the future.

Could I take this opportunity to remind you that the waste returns for quarter 1 2017 are also due to be submitted to waste.returns@cyfoethnaturiolcymru.gov.uk by the 30th April 2017.
