Routine unannounced inspection carried out by Environment Officer Rhys Thomas. Accompanied on site by TCM Paul Allport during the inspection.

Site was busy at time of inspection and storage areas appeared to be full to capacity. There was a large stockpile of metals stored on the hardstanding area which included several depolluted ELV's. ELV depolluting activities were taking place at the ELV workshop at time of inspection. The storage container for engine blocks on site was full and several engine blocks were being stored on the ground. It is good practice to ensure that engine blocks (and other oil contaminated parts) are stored in a container and covered to prevent ingress of rain. This ensures any oil contaminated fluid can be contained and prevented from running into the oil interceptor, which is there for emergency containment. Batteries were appropriately stored under cover

A small selection of waste transfer notes / hazardous waste consignment notes for outgoing wastes were viewed at the site office. These appeared to be in good order.

Some proposals for carrying out maintenance work on the workshop buildings were discussed during the visit. This may involve changing the site plans. Operator may also register waste exemptions for the external yard for storage purposes whilst work is carried out. Guidance has been sent via e-mail.
