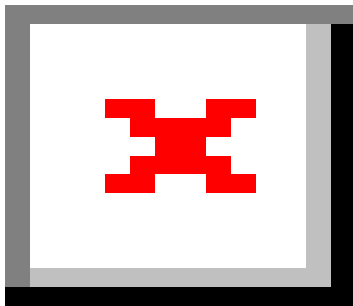

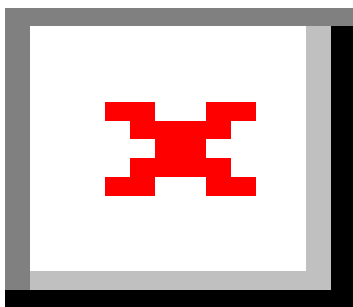

This was an unannounced inspection conducted by Steven White who was accompanied around site during the inspection.

There were approximately 25 depolluted cars on site awaiting crushing and 15 crushed ones (see photos below). Tyres are stored in the skips by the weighbridge, Chaloner's usually waits until these are full before sending them off as they then know that ~20T will be sent off.

An S2 exemption has been registered for the storage of the plastics mentioned in the previous CAR form on site

The skip from Display Recycling was checked during the inspection, all that could be seen was pieces of metal from the screens. The regulating officer for Display Recycling had raised concerns about the type of material being sent to Chaloner's (namely glass) due to the risk of lead contamination from the TV screens. This waste was not observed at Chaloner's during the inspection.

Following checks by Paul Chaloner at Display Recycling it was found that some 'sweepings' were included in the skip from Display Recycling - these had apparently been consigned to Chaloner's as 16-02-14 (discarded equipment other than those used mentioned in 16-02-09 to 16-02-13) - this waste code can be accepted by Chaloner's, the regulating officer for Display Recycling is in discussions with them regarding their categorisation of the waste.

Waste Returns were checked during the visit, these seemed to be in order.
