### **Breach**

#### *C4 - Management - Storage, handling, labelling and segregation - CAT 4 - Permit Condition 2.4.1*

Situation similar to that recorded in the inspection form for December 2014. Large number of undepolluted ELVs on site. Some of these undepolluted ELVs had started to encroach onto the hardstanding surface. The ELV directive requires that all undepolluted ELVS are stored on an impermeable surface with sealed drainage. The situation was discussed on site and I was told that these undepolluted ELVs would be moved. We also discussed moving all undepolluted ELVs to another area on site where there is more impermeable surface. This breach has been deemed a Cat 4 as the number of ELVs on the hardstanding appears to be small and there seems to have been no impact to the environment on this occasion.

You should ensure that all undepolluted ELVs are removed from any hardstanding on site by the **1st May 2015**.


During my last site inspection I observed that parts of the yard had started to deteriorate which had therefore led to a couple of large puddles on site. It was noticed that these areas had now been repaired.

It was good to see that sawdust had been used to soak up a small oil spill that had occurred next to a skip used to store engines and parts. This oil contaminated sawdust was to be disposed of as hazardous waste.

Discussed the use of a mobile shredder on site that would be used to break larger metal pieces into smaller pieces. The treatment processes within your environmental permit include shredding (see Table S1.1 within Schedule 1). This treatment process would probably have to be carried out on an impermeable surface with sealed drainage.

Apart from the breach detailed above, the site seemed to be well organised and tidy. Due to a poor market there was more waste metal on site than usual on this occasion.
