4. Details of our assessment

Site inspection of permitted asset.

Reason for inspection: Routine and because asset eventually discharges to Water Framework Directive watercourse.

Weather: Cloudy.

NB the discharge point from the Combined Sewer Overflow into the receiving watercourse is within a culvert. Therefore the discharge point could not be observed.

At the time of the inspection there appeared to be no flow coming from the Combined Sewer Overflow based upon the flow that was observed leaving the culvert.

No evidence of a discharge having occurred from the Combined Sewer Overflow was evident at the culvert - The culvert mouth was free from sewage debris and was not stained.

No evidence of a discharge having occurred from the Combined Sewer Overflow was evident (sewage debris etc) in the immediate watercourse downstream of the culvert.

Further downstream there was evidence of sewage debris in the watercourse. However, this is believed to have collected from a misconnection entering the watercourse from a unmapped surface water line below the culvert. DCWW have been made aware of this, confirmed it is not your Combined Sewer Overflow asset and the misconnection has been added to the Blaenau Gwent misconnection action plan.

Access to the Combined Sewer Overflow screen and weir point was provided by two manholes, to allow for maintenance and emergency access.

The asset was secure with steel manhole covers over the Combined Sewer Overflow screen and weir point.

Action - Please supply maintenance records for this asset within the next 15 working days.
