4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site by permit operator Mark Tucker.

C1 Staff competency/training

Under condition 1.1.4 the operator shall comply with the requirements of an approved competence scheme. This issue has been raised on the previous two site inspections, however Natural Resources Wales is yet to receive confirmation of your continuing competency.

Action – you must complete your continuing competency and submit evidence of this to NRW.

C3 Materials acceptance

Under condition 2.3.2 (a) waste shall only be accepted if: it is of a type and quantity listed in schedule 2 tables S2.1. During the inspection no non permitted waste types were identified.

G4 Reporting and notification to Natural Resources Wales

Under condition 4.2.2 of the permit you are required to submit quarterly returns within one month of the end of each quarter. As we discussed on site, these have been reviewed and no issues have been identified. Using the quarterly returns we have identified that as of **Q3 of 2021** a total of **22,569.4 tonnes** of waste material has been deposited on site, the permit allows for a total of **45,500 tonnes**.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
