## 4. Details of our assessment

### Annual monitoring returns for 2021

**Requirements:** Condition 4.2.2 requires that a report on the performance of activities over the previous year shall be submitted by 31st January each year.

**Findings:** Reporting forms for water, energy usage, and raw materials were received on 27/01/2022 in accordance with Permit requirements.

The production volume of 18,163 tonnes for 2021 was very slightly down compared to 2020 (18,198 tonnes).

Raw material usage for 2021 was 23,768 tonnes, up on the 22,019 tonnes used for 2020 and water usage of 6.55m<sup>3</sup>/t in 2021 is down compared to 8.47m<sup>3</sup>/t in 2020 demonstrating improved resource efficiency.

Energy usage for 2021 of 2.51 MWh/t was slightly up on 2020 (2.44 MWh/t).

### BREF Review

This review is almost complete and permit variations should be issued imminently.

As part of this review, three emission points to air identified as absent from the current permit were noted (A10 - A12). These are from an additional gas fired water heater and two gas fired roasters. **NRW considers this to be a breach of Permit Condition 3.1.1 (E1 - CCS3) in that they are unauthorised emissions.**

**ACTION:** It has been agreed that the Operator will apply for a variation to the permit to cover these 3 emission points by 31st March 2022.
