## 4. Details of our assessment

This Compliance Assessment Report follows a routine site inspection at Hafod Landfill site on 25 January 2022. The Area Manager and Site Manager accompanied officers during the inspection.

Immediately before carrying out the inspection, officers completed an off-site odour assessment which included the following areas: Vauxhall Industrial Estate, Heol Estate, Bangor Road and New Hall Road.

A landfill gas odour could be detected along New Hall Road. This odour was localised, transient and not considered significant. No odour could be detected at the other locations listed above.

When on site, officers detected a landfill gas odour in the south east area, near to the leachate condensate collection tank (this would correspond with the odour detected on New Hall Road). Visually, the condensate collection tank appeared to be in good condition and there were no obvious issues. However, the operator should carry out an inspection of this tank as per Action 1.

Action 1- Operator to inspect the integrity and pipework of the leachate condensate tank to ensure there is no potential for off-site odours and consider the feasibility of installing odour filtration to filter any air displaced from the tank. Provide an update to NRW by the date specified and continue to follow the Landfill Gas Management Plan for the site.

The operator is in the process of felling trees along the south east boundary of the site. Several bits of litter e.g. plastic bags, were observed in trees and tree cuttings were deposited near the site boundary. The operator explained that a litter pick would be carried out and tree cuttings removed by operatives.

The new cell (5a) is now operational and waste tipping activities have commenced. A concrete road and tipping pad have been constructed to aid vehicle movements when tipping in Cell 5a. The operator is hopeful that these improvements, combined with use of the wheel-wash, will reduce the potential for mud being tracked from the site.

At the time of the site inspection, there were no signs of mud on Bangor Road or New Hall Road.

There were a number of seagulls observed near Cell 5a. However, there were no seagulls observed off-site during the odour assessment. The operator currently manages the seagulls using an operative with a hawk.

The operator discussed their plans to upgrade the current 1000m<sup>3</sup>/hr flare to a larger capacity 1500m<sup>3</sup>/hr unit to accommodate the projected increase in gas volumes collected at the site. This upgrade will require temporarily shutting down the gas engines and gas blowers. The work is expected to be completed within a day. The operator will notify NRW

when this work is due to take place and once the upgrade has been completed.
