4. Details of our assessment

Site inspection undertaken by Michael Edwards and Linda Warrick of Natural Resources Wales.

Acceptance of Waste:

Wastes were stored as required under permit Condition 1.1.1 and in line with the current accepted Environmental Management System (EMS).

No non-compliances were identified with the wastes brought onto site as outlined in Condition 1.2.1 of the environmental permit and Table 1.2. Waste treatment was in accordance with the procedures written in the EMS with waste entering the main building prior to it being manually sorted into waste specific skips and stored in designated areas in line with Condition 2.1.1.

Site Infrastructure:

Site identification board provided on entrance to site with information required under condition 3.1.

Site Operations:

During the inspection there was no sign of mud and debris on the public roadway as required under condition 4.1. No evidence of site spillages or leaks identified during the inspection. No evidence of litter generated on site leaving containment or site boundary as required under Condition 6.5.

Miscellaneous:

Further to the site inspection the following items were identified with relation to Directly Applicable Legislation, namely the Hazardous Waste Regulations 2005 and the Duty of Care Regulations as detailed in Section 34 of the EPA 1990.

The review of consignment notes coming into the site identified a few errors that require addressing. Many of the notes had no quantity recorded. There were often no dates, time or signature on sections C, D and E. Please ensure this is rectified.

At the time of the inspection, it was noted that the asbestos skip had a sheeted top that was open and asbestos material was observed. This material was not double bagged, and any additional material could potentially damage asbestos sheets already in the skip and create airborne release of fibres. Please ensure your handling and loading procedures for this waste address these issues.

There was an exempt note dated 16/06/21 from SA14 8SF that had gone over the 500 kgs limit (680 kgs). This should have been flagged that it needed to be a registered premise. Please ensure that consignee returns are provided to all producers.

These above issues fit into the directly applied legislation category which links to Condition 1.1.1 of the sites Environmental Management System. Procedures and actions are required that will ensure these issues are addressed along with procedures to ensure checks are made prior to waste entering and leaving your site.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
