4. Details of our assessment

I met with Mike Parker(MP) and Darren Jones (DJ) on site to assess the compliance with the permit. I had done a consignee returns check prior to the site visit and established that the quantities through the site were well within the limits within the permit (3,650 tonnes).

The site has ISO14001 and has a good audit trail for documentation and record keeping. Waste coming into the site is produced by Phoenix Asbestos Recovery (PAR). Anything under 500kgs if produced by PAR should use the sites premise code which is CAQ377 (Part A 1 of the consignment note). This is valid until 10/11/22. The address and postcode of where the Asbestos was produced and removed from should be written in Part A 2 of the consignment note.

I had previously audited some of the records of asbestos coming into site and this was all in order apart from the premise code needed to reflect the comments made above. I requested for consignment notes for larger quantities to be e-mailed to me to conduct an audit on these records. I looked through a file on site which had the premise registration details of all the larger jobs that have been completed. This was well organised and up to date.

DJ asked about SIC codes and I said that 45.25 (2003) or 39.00 (2007) could be used for the asbestos removal work.

I was shown DJ's continuing competency certificate which is valid until 7/5/23. I asked for this to be e-mailed to me for NRW records.

We went over to the asbestos facility. This was locked and secure. The impermeable pavement was in good condition and the 2 containers holding asbestos were both locked inside the building. There is a maximum of 10 tonnes of asbestos at any one time allowed on site. I checked the records for the H vac and the maintenance and DOP testing which is carried out every 6 months. All was in order. The spill kit storage area was clearly labelled and well stocked.

The site is well run and has a high standard of housekeeping,
