### 4. Details of our assessment

The annual report from SRCL was received on the 14.01.2022.

The efficacy tests for 2021 are above the 95% pass rate. 100 spore strips passed out of 104 giving a 96% pass rate. The procedures outlined in WI AT Efficacy Monitoring were followed for efficacy failures and the site communicated the follow up tests with NRW.

The bioaerosol emissions as required by condition of 3.3.1 are compliant with the permit and the methodology specified in the Additional Guidance for Clinical Waste (EPR 5.07).

The site treated 8183.5 tonnes of waste in 2021 compared to 8639 tonnes in 2020.
