A routine site inspection was undertaken on Wednesday 29th June 2016.

During the inspection the following observations were made:

-

Waste Storage

Waste types were clearly segregated and appeared to be stored in a manner compliant with the Environmental Permit. No degradable wastes were stored outside and uncovered. Gas cylinders were stored in a locked container. Waste stored in skips did not appear to be having a detrimental impact on the surrounding environment.

Infrastructure and Drainage Works

At the time of the inspection, large scale groundworks were taking place as the profile of the site was being changed. It was noted that as these works were taking place, a large area of unmade ground has been exposed. As an advisory note please ensure measures are taken to prevent site surface waters escaping site. Due to the large exposed area, rainfall leaving site down the bank at the rear of the site could result in silt being carried into the watercourse. Please explore measures to prevent this from occurring.

Amenity

At the site entrance we noted trails of mud leaving site because of vehicle movements on and off site.

Please ensure that when the works are complete, vehicles do not track mud onto the roads. A build-up of mud on the roads may again result in silt being carried into the nearby watercourse. You are required by the permit to prevent operations having an impact on the local amenity. Although this appears to be a temporary problem owing to the groundworks, please ensure measures are taken in the future to prevent this from happening.

Effluent Discharge

Whilst on site we discussed a recent report regarding a discharge of effluent from a tanker on site (dated 20th June 2016). This issue will be addressed separately and you will be contacted shortly.

Summary

Please ensure measures are taken to minimise/mitigate the impact of groundworks on the environment. You may wish to explore pollution prevention measures such as hessian mats etc. to prevent the ingress of silted site surface waters into the nearby watercourse.

No non-compliances were recorded during the visit. Thank you for your time during the inspection.
