Odour Emissions

Breach of Condition: 3.2

The site was attended following several odour complaints in the Pentregwyddel Road area. Odour was detected beyond the site boundary, around a limited area of Pentregwyddel Road, and close to the area of complaint. The odour was mildly unpleasant at the time of inspection but not overpowering. Attendance on site revealed identified a similar smell of green un-shredded waste on site which had turned partially anaerobic and required shredding and de-odourising.

Gareth Walsh, the site Supervisor took immediate action and had the waste shredded and de-odourised the same day.

The breach of condition 3.2 is considered to be minor breach with an immediate site response so a CCS category 3 breach has been scored.
