4. Details of our assessment

Water Usage, Energy (Gas & Electric) and Performance for 2021.

Reinforced last year's advice given to Jane Nolan now to Chris Messham, that the operator needs to ensure the correct form and parameter information is used and titled as such.

Water usage seemed to have been labelled as Energy 1 and dated 2006 and similarly Performance 1 form was dated 2006.

Energy figures accepted via email as the following:

Electric is 1,410,000 per KWH;

Gas is 91,549 per m3.

Water Usage Mains Water - 1563 m3/year and 0.0188 m2/production man hours

Site Borehole - Nil return

River Abstraction - Nil return

Performance Production man hours - 83172 hours

Waste produced - 361 tonnes

Waste produced/production man hours - 0.0043 Tonnes/Hour

This waste figure includes wash water (approx. 275 tonnes) which is taken offsite by tanker for disposal

Permit Returns

- a. Production man hours have decreased by approx. 25% compared to 2020
- b. Specific waste stream is captured now by introducing a plastic baler to recycle customers wrapping.
- c. Waste bin collections have now been reduced by 33%.
- d. There has been no contamination or decontamination of the site in the year.

Jane Nolan has since left the company and a new contact will be in place by March 2022.
