Comments

I was informed that the site is not currently accepting any waste material. What is on site was accepted some time ago. This waste is currently only being stored in the permitted area. The operators are looking at their options with regards to how they will operate the permitted area in the future.

There is currently no Technically Competent Manager on site as required by your permit. As the site is not currently operational, attendance by a TCM is not needed. However, should the site start accepting, processing or removing waste then you will need to have TCM attendance. TCM attendance would need to be recorded in your site diary on site and made available for us to check should we wish to.

Following my visit to site I spoke with Mr D. Williams on the phone. It was suggested that a site meeting be arranged early in 2015 to discuss what the future plans with the permitted area on site are. Please either email or phone me once you are ready to have this meeting. Please also inform me once you start accepting and processing waste on site again.

You should ensure that despite being non operational at present all quarterly waste returns are submitted within one month of the end of the quarter. If the site has not been operational for the quarter then waste returns reflecting the fact that no waste has been accepted or removed should be completed.
