No breaches observed on site at the time of the inspection.

It was explained that in the past weeks the site has been concentrating on accepting waste onto site and that no waste or aggregate has yet been removed from site. There is now a mobile crusher/trommel on site which is being used to sort the waste inerts and I was informed that they had reduced the amount of incoming waste to allow them to process what they have on site. The aim is to produce a non waste aggregate at the end of the process.

We were informed that some of the first aggregate they produce will be used at Ballswood Quarry itself. Please ensure you keep a record of any test documentation you have for the aggregate you produce so that you can demonstrate that the aggregate has reached an end of waste status.

Observed that there was some re-inforced concrete on site. When I asked about the suitability of reinforced concrete for producing aggregate we were told that it would just require more crushing before it is processed to try and remove the steel bars/rods within it.

It was observed that there were waste transfer notes for waste accepted onto site though a full paperwork analysis was not carried out.

Tony Williams was not on site at the time of the visit, though we did discuss the inspection briefly on the phone later.
