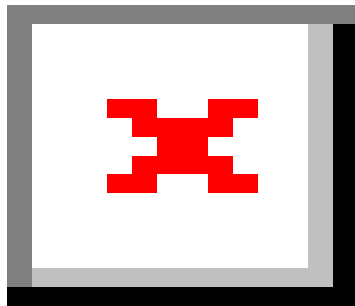

This was an unannounced inspection carried out by Regulating Officer Steven White and Environment Officer Madeleine Starks, Tony Williams met us on site and accompanied us during the visit

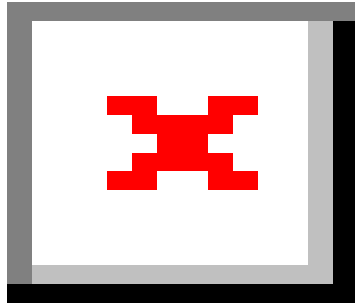
Crushing and trommel were both operational at the time of the visit, when we were in close proximity to the machinery (~20m) it was quite noisy but once we moved a small distance away the bunds cancelled out most of the noise from the machinery and it diminished considerably

Majority of the waste on site had come from utilities works (e.g. Virgin Media), on visual inspection there were no issues with the quality of material accepted onto site. Recent WAC tests and information on loads rejected from site have been forwarded to Steven White

There was a few piles of pre-treated waste stored in an area alongside the track to the site, according to the maps of the site these are stored outside the permitted area. subsequently this has been scored as a C3 breach of permit condition 2.2.1 ('The activities shall not extend beyond the site, being the land shown edged in green on the site plan at schedule 7 to this permit'). This waste will need to be moved back into the permitted boundary by 20/10/2017, approx. 4 weeks from the date of CAR form issue.

Following the previous meeting and visit to site (06/04/2017) after a number of complaints about site operations there have been no recent complaints to Natural Resources Wales regarding Inertia Ltd
