e1) Emissions: Air

Emissions to Air From the Landfill Gas Engine and Flare Stack Report

All of the flare and engine test results were under their limits.

g1) Monitoring and records, maintenance and reporting: monitoring emissions and the environment

Trace Landfill Gas Report

The level of nitrogen (balance gas) in the bulk sample is 42.7%, with oxygen at 0.3%. This is indicative of air being pulled into the site through waste. Balance gas should be reduced across the site as it is capped. This is usually achieved by increased field balancing and a review of wells and performance on the site.

The bulk gas should be analysed for carbon monoxide (laboratory not field sample) as the methane levels are below 40% and the balance gas is high. This is to check for any heating effects in partially aerobic waste.

The exposure limit for benzene is 1ppm (per 8 hour TWA reference period) / 3.25 mg.m3. Benzene is elevated at 2.1mg/m3 but not quite at the 8 hour occupational exposure limit.

Vinyl chloride is very close to the occupational exposure limit but again does not exceed it.

There are chlorine containing chemicals in the raw gas (albeit at low levels) so there is a chance of dioxin formation should the flare temperature fall below 500 degrees centigrade.
