Environment Officer had a meeting with Garry Smith (Operations manager) prior to the site inspection. Amongst some of the topics discussed were the recent odour monitoring that has being undertaken on the biofilter.

It was agreed that as a result of the recent odour monitoring and associated investigatory work on this matter a report will be sent to Natural Resources Wales detailing the findings. Natural Resources Wales will respond to this through a separate CAR 1 form/s.

A letter will also respond to NRW correspondence back in May 2014 which contained some agreed actions in regards to the biofilter efficiency reporting. Amongst some of the actions was to submit an updated odour management plan which I was informed today is nearly complete, it will also incorporate valuable information gathered and learnt during the recent odour monitoring investigatory work.

It was also discussed that the site is to respond to previous CAR 1 form sent to FCC Environment on the 2nd May 2014 CAR 1 ref 100079/0204314 which requested an explanation to some issues noted in the Bioaerosol monitoring reports.

I was informed that the content of the CAR 1 form has been raised with D&F Associates Limited who undertake the monitoring and that the response will be forwarded to Natural Resources Wales as soon as possible. Once we have bottomed out these matters Natural Resources Wales will be in a position to respond to the recent set of monitoring submitted to us.

Following the meeting I was accompanied by Paul Wycherley and his colleague to undertake a site inspection. Due to the time of year the site was not at full capacity. Out of the six tunnels, Only tunnel 4 was full, whilst tunnel 5 was in the process of being emptied.

A recently tipped green waste load was evident in the reception bay, this load was heavily contaminated with general waste. Environment officer was informed that this load was going to be rejected

The material recycling facility was also inspected.

The overall site appeared tidy and no issues were noted

In the site office the site diary was inspected and the installation inspection daily log. The log appeared to be filled in and entries evident in the site diary (for example a record of today's rejected load was evident in the site diary).

Copies of waste transfer notes were briefly looked at, these included Waste transfer note ref 31661 for IVC rejected material from compost and a seasonal note ref 31659 for pre maturation compost to the Gowy site. No issues were noted.
