A biofilter odour sampling exercise was undertaken by the operator in August 2014 to detail the efficiency and effectiveness of the biofilter in accordance with Table 3.1 of the permit. The report was submitted formally in December 2014 although discussions were held between the operator and Natural Resources Wales regarding the results prior the submission of the report.

In summary the results conclude that “the calculated difference between the mean inlet and mean outlet is 66.2%. This is well below the performance calculated during the previous sampling campaign in August 2013, which calculated a 99.3% performance”.

The operator is of the opinion that these results are abnormally high and It was agreed that a repeat odour sampling exercise and investigatory work on any causes of reduced biofilter efficiency will be carried out.

Environment Officer has been informed that a report will be submitted for the most recent biofilter odour sampling exercise no later than 2nd February 2015. Once Natural Resources Wales has reviewed this report we will respond to both biofilter odour sampling exercise and assess compliance with the relevant permit conditions.

In this document 'Natural Resources Wales' means the Natural Body for Wales established in Article 3 of the Natural Resources Body for Wales (Establishment) Order 2012
