**We have completed a Natural Resources Wales Initiated Variation to your permit**

We have completed a Natural Resources Wales Initiated Variation to your permit to include limits which you must operate below in order to remain as a permitted waste activity, following the introduction of the Industrial Emissions Directive. Failure to comply with the limits may result in enforcement action. We have undertaken this variation as you previously indicated that although your site may have the capacity to operate over the thresholds detailed in the amended Environmental Permitting Regulations 2013, you have chosen to limit your activities through operational measures detailed in your updated Environment Management System, as agreed with your sites Compliance Officer. We have therefore incorporated these limits into your permit in order for us to regulate your activities against these limits from July 7<sup>th</sup> 2015 Onwards.

We are satisfied that you can continue to carry out your activities in accordance with the variation, without harm to the environment or human health. I enclose a notice showing the changes to your permit. Please keep this in a safe place with your other permit records.

Please note that as you have chosen to remain as a waste facility, there will be no changes to the way you are charged, this will continue as normal.

## Rights of appeal

If you are not happy with any permit condition that has been imposed by the variation you may appeal to the Welsh Ministers. If you want to appeal any condition imposed as a result of your application you must make your appeal no later than six months from the date of the variation notice. If you want to appeal any condition we've added as an Natural Resources Wales initiated variation you must make your appeal no later than two months from the date of the notice.
