The site was locked up and no one was present at time of site visit. Officers were only able to assess the security arrangements and not fully assess the waste operation.

Large stock piles of waste material (much more than our previous visit) were observed in the compound and a loader and excavator were present on site. A visual inspection from outside of the gates was made and the type of waste appeared to be suitable for the waste operation.

Please be aware that your standard rule set will soon be changing from your current SR2010 No7 to a SR2017 No1 as detailed in previous correspondence. We will be contacting you again separately in due course to facilitate this.
