The gates to the waste processing / storage yard were open so we were able to view inspect the premises. There were a few stockpiles of waste a stockpile of processed waste on site. A 'Gower plant' lorry arrived whilst I was onsite and deposited a load. All waste types appeared to be permitted under the conditions of the permit.

No processing of waste took place during the visit but a large crushing machine was present on site.
