During time of the visit Ritchie Thomas and Helene Wright of FCC Environment were present on site accompanied by Mohammed Taiq of BSI who was undertaking an audit on site.

The site appeared tidy and no breaches of permit observed.

Amongst some of the office paperwork inspected was the site diary and the daily site log. No issues were found.

The only observation noted during the visit was a minor amount of leachate deriving from the storage of PAS100 compost stored within a roll on roll off skip on site which was flowing across the yard. The risk of this effluent reaching surface water drains on site was discussed. Helene Wright advised that they would look into this matter and will be dealt with accordingly.
