4. Details of our assessment

Site handover inspection 11th Oct 21

Inspection of Lagoon and associated infrastructure. Green algal growth was noted over the lower section, along with proximity of trees and overhanging branches. Please ensure preventive maintenance is put in place early to minimise fallen leaves, twigs and other debris entering the leachate pipe as agreed (BGCBC Highways department)

Duty pump in operation. During the inspection fumes from the diesel engine were evident throughout the surrounding locality, suggesting poor combustion efficiency. We consider this a non-compliance with the permit.

Refer to subsequent email 14th Oct for preventative maintenance and to progress the HEP scheme.

Separately, please provide report requested 16th Aug for the patch repair work done w/c 22nd Mar 21.
