Routine compliance inspection of the permit EPR-PB3393HD conducted by officers Jonathan LEE and Lucy ORAM at 10:30am on the 1st February 2019. The permit is held by Roydon Bottle Recycling Limited for the processing of plastic wastes. Weather cold and light snow. Officers met with EHS manager and site TCM, Janet Rawlings.

Compliance

Officers were shown all parts of the permitted facility. All waste stored within the building, no issues apparent with storage or infrastructure. No compliance breaches were identified during the inspection, categories have been scored as compliant accordingly.

Quarterly waste returns up to date, thank you for submitting these on time.

Fire Prevention and Mitigation Plan (FPMP)

FPMP guidance (GN016) and its potential to stipulate changes in the operation of the site was discussed. Although there is no current permit requirement for an FPMP, it is likely the site permit will undergo an NRW-led variation to require one in the near future. A draft version of the site FPMP is currently being prepared by the operator. If input or assessment of this draft plan is required, please contact your regulatory officer. It should be noted that the current guidance is due for review in August of 2019.
