Waste Return Review

A review of the waste returns submissions for permit EPR-YP3194FU has been completed. Condition 6.1.1 of your permit requires you to submit within one month of the end of each calendar year a summary of waste quantities and types accepted on to and removed from site for that year.

In CAR form dated 26th October 2015 you were made aware that you had breached condition 6.1.1 and a CCS score was applied. Also in the CAR form dated 26th October 2015 you were requested to ensure that this breach does not reoccur. Unfortunately, the same breach has occurred again as we have not received the waste returns for 2015. As a direct result of this breach a CCS score 3 has been now been applied and issued with a warning.

Action Required

The missing annual waste returns for both 2014 and 2015 must be submitted to waste.returns@cyfoethnaturiolcymru.gov.uk no later than the 31st October 2016. A management system must also be implemented by the 31st October 2016 to prevent this breach from occurring again in the future. A copy of the waste returns template has been enclosed with this CAR form for your use.

When completing the form please ensure that you use your permit number EPR-YP3194FU and not your EAWML number. Also in box 2.2 please enter your site type as A19a: ELV Facility. Could I also remind you that your waste returns for 2016 are due to be submitted by 31st January 2016.
