Site had stopped accepting waste onto site in March 2017 as it was coming to the volume limit on its permit, there was approximately 3000T left that could be accepted on this permit. Advice was given about how to apply for another permit so that more waste could be accepted on site - the forms etc for the application of a new permit were filled in and ready to be sent off, once they have been received by NRW Permitting Centre a Permitting Officer will be allocated to the case and will get in touch with the applicant to go through the process.

There were no issues with the type and quality of the wastes accepted on site.
