4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resource Wales.

Waste Storage - B4, C2, C3 and C4.

Site tour conducted during the inspection, waste stored in appropriate containers and designated areas inline with condition 1.1.1a of the environmental permit. Wastes were well segregated in labelled skips. No non-permitted wastes identified during the inspection.

During the inspection, it was noted that the wood store container was at capacity, operator confirmed during the inspection that CRES have been contacted to remove and replace the container.

Staff competency - C1

Evidence demonstrating the continuing competency of Kevin Jones has been provided as required under condition 1.4.3 and is valid until 17/08/2022.

Infrastructure - B3.

During the inspection no issues were identified with the drainage of the site with all wastes stored on an impermeable surfaces with no pooling of water and drains kept clear of loose debris or litter. in line with conditions 2.1.2 of the permit. No issues with perimeter fencing, or site security during the inspection

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
