4. Details of our assessment

Ffridd Rasmus - Landfill Gas Extraction System Inspection

22 December 2021

Gas infrastructure and efficient extraction must be maintained at the site post closure under the terms of the Landfill Directive and under the following condition of the permit:

2.8 Landfill Gas Management

2.8.1 The operator shall take appropriate measures, including, but not limited to, those specified in any approved landfill gas management plan, to:

- (a) collect landfill gas; and**
- (b) control the migration of landfill gas**

The landfill gas extraction system was inspected for flow and quality and balance across the field. Readings at the gas compound were as follows

CH4: 50%

CO2: 21.1%

O2: 0.7%

CO: ppm

H2S: 5ppm

Balance Gas: 27.7%

Relative Extraction Pressure: -2.19mb

Total volumetric flow: 32m3/hr

The readings show high quality and low flow gas with raised levels of balance gas. This is due to the combined long-term extraction entraining steady but low volumes of air into the system, which is stripped of oxygen as it moves through the waste. The flow levels are so low that this does not constitute an area of concern for NRW at this time.

Field balancing appears in harmony with gas production and very low extraction pressures are being exerted on the gas field in a steady manner to ensure efficient gas capture.

Hydrogen sulphide levels are low and low CO levels show that the site is not being over extracted and there are no heating effects.
